Discrepancy Details	
Total Amended Discrepancies	<p>In Certified Results, there were 12 ballots more tabulated than received vote credit due in SCORE.</p> <p>Based on ballots found needing duplication in this Recount, we believe this discrepancy represents finding and correcting user error from the General Election where 3 ballots were run through tabulation possibly twice to balance a batch that actually included a ballot with red ink or other issues that was unable to tabulate and not in the tally.</p> <p>Each day and at the end of the recount the number of ballots tabulated has been 100% reconciled and matched with all recount logs, labels, and manifest.</p>
